WHEREAS, Catholic Charities of Buffalo was selected as the second annual winner of the prestigious Torch Award by a panel of independent judges; the Better Business Bureau Foundation of Upstate New York developed this award to bring attention to the practices which nonprofits employ to generate a high level of trust among employees, donors and the community; and

WHEREAS, In 2015, Catholic Charities of Buffalo served nearly 132,000 individuals and families in need throughout the region; the organization offers comprehensive services particularly to those in need and to those

who are most vulnerable without regard to religion, race or age; and

WHEREAS, Operating at the highest levels of leadership, character and commitment to its mission and ethics, Catholic Charities of Buffalo believes in empowering individuals, children, and families to achieve and maintain meaningful, healthy and productive lives; and

WHEREAS, Under the able leadership of Dennis C. Walczyk, Chief Executive Officer, Catholic Charities of Buffalo offers services such as helping to administer the WIC program, counseling, and basic housing and food assistance as well as school-based services; and

WHEREAS, The Torch Award for Philanthropic Excellence is a testament to the services Catholic Charities of Buffalo provides to members of the community, and to the impact it has on Western New York; and

WHEREAS, It is the custom of this Legislative Body that when individuals and organizations of such noble aims and accomplishments are brought to our attention, they should be celebrated and recognized by all the citizens of the great State of New York; now, therefore, be it
