WHEREAS, Over the years, Daisy Vale has volunteered for numerous local organizations including FUENTE, a Hispanic Advocacy organization which served Newburgh residents in the 1980s; she has also led many fundraisers for the Nora Cronin Presentation Academy and served on its Board of Directors; and

WHEREAS, In addition, Daisy Vale has volunteered and served on the Board of Directors of The Greater Hudson Valley Family Health Center, and helped organize its Baile Latino fundraiser; and

WHEREAS, Throughout the entire period of her community service, a period of constructive involvement, Daisy Vale has stood constant in dignity, good grace and humor; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Daisy Vale has displayed throughout her life; and

WHEREAS, It is the sense of this Legislative Body that when individuals of such noble aims and accomplishments are brought to our attention, they should be celebrated and recognized by all the citizens of this great Empire State; now, therefore, be it
