children who are out of school are busy, safe and entertained; and

WHEREAS, Over its distinguished 23 year history, the Dorothy and Lewis B. Cullman Child Development Center has been the backbone of the community, supporting and giving form to the residents and communities which it serves; and

WHEREAS, The success of the Dorothy and Lewis B. Cullman Child Development Center is in direct correlation to the efforts of its staff, whose involvement is, and always has been, characterized by an impressive commitment, unbridled enthusiasm, and an uncompromising standard of excellence in all endeavors on behalf of the business and the community it serves; and

WHEREAS, This auspicious occasion presents an opportunity for this Legislative Body to recognize and pay tribute to the Dorothy and Lewis B. Cullman Child Development Center; and
