WHEREAS, During his tenure, Professor Lambert has earned the admiration, esteem and affection of all of his colleagues, and he has brought an uncompromising standard of excellence to his work and a warm sense of caring and concern to every young person he has educated; and

WHEREAS, Educators such as Professor Thomas J. Lambert provide a tremendous service to the future of our State and Nation, inspiring generations of young people in their educational journeys and ensuring their success in their future years; and
