WHEREAS, Actively involved in Congregation Beth Tikvah, Ira Kase has been a member of the Board of Trustees and researched government grants for synagogue security; he has also been involved with Shabbat dinners, and maintained the CBT website and phone tree; and
WHEREAS, Today, Ira Kase serves as the Men's Club Co-Membership Vice President, and is a member of the Long Term Planning Committee; he also maintains the income record keeping as a member of the Journal Committee and is a member of the wait staff for the Sisterhood show, along with the former Catskill Crew; and
