WHEREAS, With a steadfast and unwavering commitment to the Finger Lakes Region, Gretchen and Peter Koch have contributed to several community projects; Gretchen has served on the board of several organizations including the Seneca Falls Library, the Historical Society, the National

Women's Hall of Fame and Family Counseling Services of the Finger Lakes;

WHEREAS, Additionally, Gretchen Koch has volunteered with the Seneca County Children's Committee and the House of Concern; and

WHEREAS, Peter Koch has been a member of the Board of Portal de Belen, St. Patrick's Parish Council and St. Joseph's Parish Council; he has also served as President of the Board of DeSales Regional High School;
