WHEREAS, Barbara Michalski has been called upon to contribute her time and talents to countless civic and charitable endeavors and has always given of herself unstintingly; and

WHEREAS, Barbara Michalski currently serves as a member of the Albany County Disaster Response and Recovery Committee and the Community Investment Committee for the United Way as well as the Rensselaer County Long Term Care Council; and
