WHEREAS, In December of 2012, Carmen Duncan, a social entrepreneur, founded Mission Accomplished Transition Services; for almost four years, this vital non-profit organization has strived to prepare aspiring young professionals for the global economy by providing access to coaching, job training and professional development; and

WHEREAS, In addition to her invaluable work with Mission Accomplished, Carmen Duncan serves on the Capital District chapter Board of the New Leaders Council, and acts as a mentor with the Sponsor-A-Scholar program; she is also an appointed member of the NYS Runaway and Homeless Youth Act Advisory Board; and

WHEREAS, For her steadfast and unrelenting commitment to her community, Carmen Duncan was recently acknowledged by The Black Women's Association of Albany as a Woman of Distinction and the Albany Business Review as one of the top "40 under 40" up-and-coming executives who will

shape the future; and
