WHEREAS, For the past eight years, Brian DiGiovanna rendered faithful, conscientious and valuable service to the Association of Supreme Court Reporters; and

WHEREAS, With a steadfast and unwavering commitment to his profession, Brian DiGiovanna regularly travels to Albany to meet with legislators to discuss issues that affect court reporters; he helped launch paperless writer, and has created 10 high tech courtrooms in New York State; and

WHEREAS, Throughout his tenure, President Brian DiGiovanna promoted the use of real-time by introducing real-time seminars and traveling to courthouses to educate association members on how to configure their equipment in furtherance of real-time compliance; and

WHEREAS, Under the able leadership of Brian DiGiovanna, ASSCR has sought to improve its members' wages, benefits, working conditions, and job security; he also worked with Court Administrators to create solutions to the court system's problems; and

WHEREAS, This esteemed man has made more than 200 presentations to judges and dignitaries from around the world on court room technology; furthermore, he completed the first real-time case in the State New York, as well as the first and only real-time criminal case; and
