WHEREAS, Fun for families and die-hard bowlers, league bowling is available on Sunday, Monday and Tuesday evenings, "QuizBowl " trivia night is offered on Wednesday, Family Nights on Tuesday, and Vinyl Showcase is held on Thursdays, complete with free music, menu specials and half-price bowling; and

WHEREAS, Committed to developing its community, Atlas Bowl has graciously supported local agriculture programs and non-profit organizations by engaging various groups in hosting events and fundraisers at Atlas Bowl; and

WHEREAS, Since its inception, Atlas Bowl has been instrumental in creating high quality jobs in a small community, and has become an anchor of downtown Trumansburg; Todd Parlato has been the heart and soul of Atlas; he has tirelessly engaged local businesses, community members and more to create not just the restaurant he wants to run, but one the community deserves; and
