WHEREAS, Attendant to such concern, and in full accord with its long-standing traditions, this Legislative Body is justly proud to commemorate the 50th Anniversary of the Schechter School of Long Island, to be celebrated on Thursday, March 30, 2017, at Old Westbury Hebrew Congregation, Old Westbury, New York; and

WHEREAS, The Schechter School of Long Island is a vibrant Kindergarten through grade 12 Jewish Day School whose dual curriculum of excellence educates and empowers its students to be critical thinkers, ethical leaders, and globally engaged citizens, striving to achieve their full potential and ensuring a vibrant Jewish future; and

WHEREAS, The Schechter School of Long Island's reputation for primary and middle school excellence began in 1967, with the high school opening its doors in 1994 to great acclaim; its students achieve the highest standards and gain acceptance to some of our nation's finest colleges and universities; and

WHEREAS, While taking on great academic and intellectual challenges, the students of the Schechter School of Long Island live out the Jewish ideal described by its namesake, 19th century scholar Rabbi Solomon Schechter, that "Judaism permeates the whole of your life"; and

WHEREAS, At the Schechter School of Long Island, the morals, ethics and beliefs of a dynamic Jewish life are core to its students' intellectual, social and spiritual growth, compassion for community, love for Israel and the Jewish people, and commitment to social responsibility; and
