WHEREAS, A senior at Hoosick Falls Central School, Anna V. Brewer, the daughter of Joyce and Todd Brewer, is a member of Girl Scouts of America Troop 1144; after graduation, she plans on majoring in nursing in college; and

WHEREAS, Athletically and academically, Anna V. Brewer has proven herself to be an unbeatable combination of talents, reflecting favorably on her school; she is a member of the National Honor Society and was named a scholar athlete; and

WHEREAS, A multi-talented musician, Anna V. Brewer plays an instrument in five different school bands and the Hoosick Falls Community Band; and

WHEREAS, In addition, Anna V. Brewer was chosen as one of the 13

Kids Who Care in 2016, and as a Rensselaer County Legislature Youth of the Month in 2017; and

WHEREAS, Anna V. Brewer is an active and vital participant of her community; she is a volunteer with the Hoosick Area Church Association and a junior member of the Town of Hoosick Rescue Squad; and

WHEREAS, America has achieved her greatest heights of glory through the dedication, determination and tireless efforts of the outstanding citizens of this Nation; and

WHEREAS, It is only with the continued diligence and devotion of our youth, tomorrow's leaders, that America will maintain her glory; and

WHEREAS, The Girl Scouts of America and its members are dedicated to the development of character and leadership in the youth of this Nation; and

WHEREAS, Since 1919, Senior Girl Scouts have sought to cap their years in Girl Scouting with the prized Girl Scout Gold Award, which challenges girls to change the world; and

WHEREAS, In order to earn the Girl Scout Gold Award, a girl must complete a rigorous set of service, leadership development, and skill-building tasks leading up to the final and most challenging requirement, the design and completion of a Take Action Project; this project must be an issue of interest to the girl and her community, employ team-based solutions, and educate and inspire others; and

WHEREAS, For her project, Anna V. Brewer spent over 800 hours designing and then installing fitness stations, historical markers and a bench along the Hoosic River Greenway; she enthusiastically encouraged

the community to get involved by sponsoring the signs and helping install the stations; and

WHEREAS, This outstanding young woman has been involved in Scouting for years, has lived up to Scouting's ideals and has attained all of the necessary achievements; and
