is awarded to the Best Craft Beer in New York State, for their Whale
Brown Ale at the TAP New York's Craft Beer and Food Festival held April
29-30, 2017; and

WHEREAS, Since its inception, Community Beer Works has strived to

"Embeer Buffalo" by fostering the development of the beer culture within Buffalo, making it one of the premier beer locations in the country; and

WHEREAS, In 2013, Community Beer Works' "The IPA" was awarded 2nd Place in the Brewing News' National IPA Championship, and was named the Best New Brewery in New York State at the Annual RateBeer Best Awards Banquet and Beer Festival; and

WHEREAS, As this exceptional business continues to grow and prosper, it underwent a large expansion project in 2016; dedicated to the community it is a vital part of, Community Beer Works was instrumental in encouraging economic development by renovating two buildings, both of which were historical taverns located on Lafayette Street in the West Side of Buffalo and Niagara Street in Niagara Falls; and
