WHEREAS, During the title match, this talented young athlete had a slow start, trailing 2-1 until his Coach, Phil Szumlaski yelled "burn him, burn him"; using the burn, a defensive move which leads to a big scoring move, Ryan Ferro clinched his second straight state title; and

WHEREAS, This remarkable athlete finished his high school wrestling career with an exemplary 181-36 record, including four Section 9 titles, two state titles and the incredible mark of never losing a home match; after graduation, he plans on wrestling in college; and

WHEREAS, Academically and athletically, Ryan Ferro has distinguished himself as a young man of superlative ability, talent, and maturity, establishing standards of excellence and achievement, purposefulness of life, and responsibility rarely achieved in youthful years; and

WHEREAS, In addition to his successful wrestling career, Ryan Ferro is also a talented football and baseball player; for his superior athletic prowess, he was the recipient of numerous awards and accolades including the C.A. Morgan Award, and was named the Bill Garcia Agency ALLSTATE Student-Athlete of the Week, and will be recognized as a Scholar-Athlete; and

prowess, speed and agility, Head Coach Phil Szumlaski worked hard to hone the skills of this champion, teaching this outstanding athlete lessons which will prove invaluable both on and off the mat; and
