WHEREAS, In 2011, The Reverend Dr. Marie J. Poux Bernard received her pastoral credentials at Universal Theological Seminary, Inc., and pursued a doctorate degree at Macedonian University in 2013; today, she is both the founder and President of the International Pastoral Women Association, Inc., a non-profit organization which examines various issues among women pastors, religious congregations and other faith-based organizations; and

WHEREAS, During her 35 years in New York City, The Reverend Dr. Marie J. Poux Bernard worked in collaboration with several humanitarian sectors visiting shelters and feeding the homeless; she also performed missionary work in Santo Domingo, Haiti and the Bahamas, providing much needed assistance to a diverse population; and

WHEREAS, It is the sense of this Legislative Body that those who enhance the well-being and vitality of their community and have shown a long and sustained commitment to excellence certainly have earned the recognition and applause of all the citizens of this great Empire State; now, therefore, be it
