WHEREAS, Throughout his more than 40 years with this vital organization, Lon Tytell chaired countless initiatives including the Bicycle Program, Hot Shot Basketball Project, the Shopping Party for Children in Need, the Cotton Candy Project, Easter Egg Hunt and the Holiday Food Basket; he was also recognized as one of three Outstanding District Directors of the Year in all of New York State; and

WHEREAS, Lon Tytell joined the Warwick Lions Club in 1978, during which time he served on its Board of Directors for 20 years, and as a representative to the committee that started the Annual Senior Citizen Picnic in the Town of Warwick; and

WHEREAS, As a member of the Warwick Lions Club, Lon Tytell was

instrumental in the success of numerous programs including, the Ultimania Basketball Project, the Lions Bunny Project, the Labor Day Race, and the ringing of the bell for the Salvation Army; in addition, he served as the organization's Lion Tamer, Secretary, Vice President and President; and

WHEREAS, Throughout the entire period of his community service, a period of constructive involvement, Lon Tytell has stood constant in dignity, good grace and humor; and

WHEREAS, With him throughout has been his wife, Rosita, who feels privileged to be a part of his life and rejoices in his achievements; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Lon Tytell has displayed throughout his life; and
