WHEREAS, For her tireless efforts, Kathy Graves was appointed to the Yonkers New York Rising Community Reconstruction Committee, sponsored by the Governor's Office of Storm Recovery; she also serves as a community representative to the Bronx River Advisory Board; and

WHEREAS, In addition to caring for her community, Kathy Graves owns and operates her own consulting firm, Admissions Blueprint, where she counsels college-bound students through the admissions process; and
