WHEREAS, In addition, with a steadfast and unwavering commitment to the community, Greg Furlong serves on the Schoharie County Child Development Council as a policy council member, and as a youth soccer coach; and

WHEREAS, Throughout the entire period of his community service, a period of constructive involvement, Greg Furlong has stood constant in dignity, good grace and humor; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Greg Furlong has displayed throughout his life; and
