WHEREAS, The success of the Albany JCC is in direct correlation to the efforts of Thomas Wachunas, whose involvement is, and always has been, characterized by an impressive commitment, an unbridled enthusiasm, and an uncompromising standard of excellence in all endeavors on behalf of the organization and the community it serves; and

WHEREAS, Widely known for his extraordinary dedication to Israel and the local community, Thomas Wachunas' philanthropic and leadership endeavors continue to inspire all of those who are lucky enough to know him; and
