### Flooding Update, Resources and Information

Additional Resources for Communities Impacted by Lake Ontario Flooding

For local municipalities:

- \$10 million in state funding has been available to assist eligible local municipalities.

- The new investment will support flood recovery efforts including repairs to flood walls, roads, sidewalks and culverts, as well as public water and sewer infrastructure.
- The funding is made available through New York State Home and Community Renewal.
- The program will be open to applications for funding from municipal governments in Cayuga, Monroe, and Wayne Counties – among the other counties that were identified in Governor Cuomo's May 2, 2017 emergency declaration.

For small businesses:

- \$5 million in grants available for small businesses that have experienced physical damage or loss as a result of the flooding in communities along Lake Ontario.
- Up to \$20,000 to support the repair or replacement of damaged or destroyed real property and other tangible assets, including equipment, furniture, fixtures, supplies and inventory.
- Funding will be provided through Empire State Development.
- Applications will be made available in June.

The New York State Emergency Response Mobile Command Centers will be in the 54<sup>th</sup> District this week. ### **Wayne County**

- 255,000 sandbags
- 2 sandbaggers deployed
- 47 National Guard Members deployed
- State sandbagging operation at 7290 Ridge Road in Sodus
- Local sandbagging operation at 7452 Seaman Street in Sodus Point
- 2 hoses and pumps
  - 2 - 6" pumps
