WHEREAS, Since 2012, Tyrone Muse has held the title of President and CEO of Visions Federal Credit Union; in this capacity, he oversees a \$4 billion financial institution, with 550 employees serving nearly 184,000 members in three states with its headquarters based in Endwell, New York; and

WHEREAS, A devoted father and an enthusiastic sports fan, Tyrone Muse is dedicated to helping the youth of his community; he sponsors a free track program, and generously supports several local school districts and colleges; and

WHEREAS, Tyrone Muse enjoys watching his oldest daughter play basketball on the Vestal High School JV team, and his youngest daughter play soccer; he also attends many Binghamton University basketball games, and is an active member of the Jewish Community Center's Men's Basketball League; and

WHEREAS, With him throughout have been his wife, Crystal, and their

two daughters, Mya and Olivia, all of whom have shown him love and support and rejoice in his many achievements; and
