WHEREAS, Under the able leadership of Sharon Content, CPNYC embraces and supports the children of incarcerated parents, empowering them to break the cycle of intergenerational involvement in the criminal justice system; and

WHEREAS, Furthermore, the agency currently serves 350 children and families each year and is proud to report that no young person, in the 10-year history of the organization, has been involved with the juvenile or criminal justice systems; and

WHEREAS, A native New Yorker, Sharon Content is a respected alumna of Howard University; and

WHEREAS, The success of Children of Promise is in direct correlation to the efforts of President Sharon Content, whose involvement is, and always has been, characterized by an impressive commitment, an unbridled enthusiasm, and an uncompromising standard of excellence in all endeavors on behalf of the organization and the community it serves; and

WHEREAS, Throughout the entire period of her community service, a period of constructive involvement, Sharon Content has stood constant in dignity, good grace and humor; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Sharon Content has displayed throughout her life; and
