WHEREAS, After receiving an associate's degree in applied science in retail business management at Niagara County Community College, Cheryl Chamberlain went on to earn a bachelor's degree in business and distributive education from Buffalo State College in 1992, and a master's degree in 2002; and

WHEREAS, Cheryl Chamberlain began her illustrious career in Grand Island as a substitute teacher before working as a teaching assistant for four years; in 2006, she took on a permanent position as a business teacher and school-to-work coordinator, where she built the DECA business club from six members in 2006 to over 160 members today; and

WHEREAS, Furthermore, she has been instrumental in re-establishing the school store, renaming it Casey's Corner, after her friend the late George Casey, who was a member of the school board; the success of the store spurred the opening of a new concessions stand, Casey's Counter,

which gives back to the students through scholarships and funding of programs; and

WHEREAS, With her throughout have been her husband, Gregory, and their two daughters, Brooke and Sarah, who have all shown her love and support and rejoice in her many achievements; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Cheryl Chamberlain has displayed throughout her life; and
