## Senator Helming Announces Local Veterans Hall of Fame Nominees

GENEVA – Senator Pam Helming today announced that 120 military veterans from the Wayne-Finger Lakes region have been nominated by their family members and friends for the New York State Senate Veterans Hall of Fame. The local veterans reside in all six counties that Senator Helming’s district covers, represent all five branches of the U.S. military, and range from the World War II and Korean War eras, the Vietnam War and Cold War eras, and the current Global War on Terrorism era. Senator Helming accepted nominations at her District Office and through her website during the late summer and early fall in preparation for a series of Veteran Recognition Events in November to honor all of the nominees and coincide with Veterans Day.
