WHEREAS, With a steadfast and unwavering commitment to her community, Melissa Connolly has served the Long Island Women's Agenda as Vice President and President; additionally, she was a Board Member for the YMCA of Long Island and the Long Island Visitors and Convention Bureau, and a Member-at-Large of the Board of Directors for the Girl Scouts of Nassau County, where she served as a co-chair for their Annual Awards Luncheon; and

WHEREAS, A longtime Girl Scout leader and school organizer, Melissa Connolly was a co-founder and founding chair of the Girls Go the Distance Walkathon; she is also the proud recipient of Girl Scouts of Nassau County's Honor Pin and Thanks Badge; and

WHEREAS, Prior to her illustrious career at Hofstra University, Melissa Connolly served as Director of Communications for a New York State Senator, and as a Director of Marketing for Farrell Fritz, P.C., one of Long Island's largest law firms; and

WHEREAS, In 1989, Melissa Connolly received a Bachelor of Arts degree in Communication from Hofstra University, where she was a member of Alpha Epsilon Rho; she went on to earn a Master of Fine Arts degree with distinction in Creative Writing in 2017; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Melissa Connolly has displayed throughout her life; and
