CONGRATULATING Shane K. Sanford upon the occasion of his retirement after 35 years of dedicated service to the Thousand Island Bridge Authority

Authority, Shane K. Sanford was instrumental in the success of countless
projects, including the restoration of the Boldt Yacht House on
Wellesley Island, and the renovation of the first floor of the
property's Alster Tower; and

WHEREAS, In addition, he oversaw the annual rehabilitation of Boldt Castle, and was responsible for wedding services held on the property; and

WHEREAS, Under the able leadership of Shane K. Sanford, Boldt Castle and Boldt Yacht House have seen significant growth, welcoming more than 6.5 million visitors and hosting more than 1,000 weddings; he also played a vital role in these two landmarks attracting more than 215,000 visitors in 2018 alone; and

WHEREAS, Upon his retirement, Shane K. Sanford will remain involved in the legacy of the Boldt Family by assisting the Northern New York Community Foundation with administering the George C. Boldt Scholarship to its first recipients in 2019; and

WHEREAS, Shane K. Sanford is a shining example of the impact a person can have on the betterment of his community; through his tireless dedication to the Thousand Islands Bridge Authority, Boldt Castle and its related facilities, this extraordinary man has made a tremendous impact on the North Country; and
