UPDATE

IMPORTANT update for people who have been waiting more than 72 hours to hear back about their unemployment claims. The problem might be due to a glitch in the NY State Dept. of Labor website. See important information about the glitch and a step-by-step guide on how to fix it below!

For the most part, once your application has generated a confirmation number, the DOL should **actually** call you back within 72 hours. But many people's applications never generate a confirmation number, which leads to the claim getting lost in the system.

Goal: Get confirmation number like this:

| Step 1 | Your first step is to claim credit for the current week in order to validate your claim. You must do this beginning Wednesday, 04/29/2020, but no later than Saturday, 05/02/2020. Claim credit by clicking on the link below. |

Once your application has generated a confirmation number, the DOL should **actually** call you back within 72 hours. If you were only sent to this page you probably did not receive a confirmation number. In order to generate your confirmation number, please follow the steps below:

1. Visit <http://labor.ny.gov> and click the "Services" tab.

To complete your claim, a Department of Labor call center agent will call you within 72 hours. You do not need to contact the Department of Labor -- we will contact you at the number that is listed in your claim. 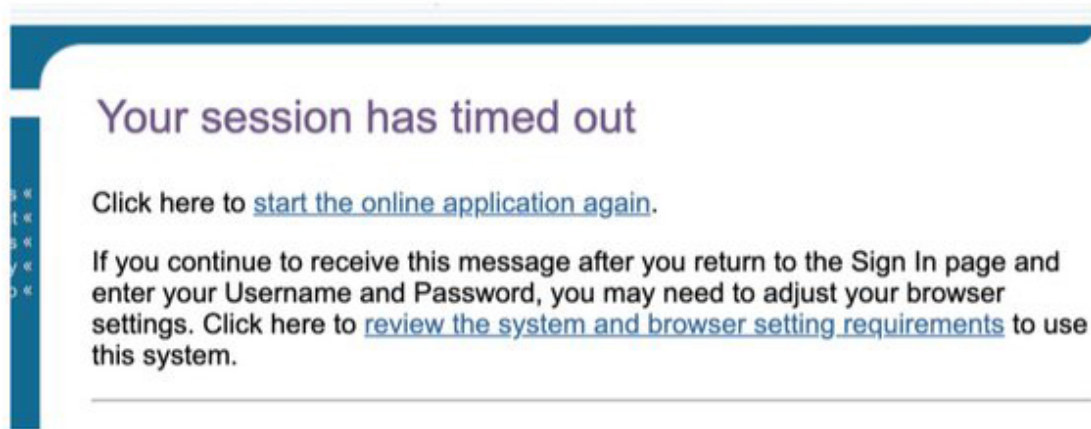

10. You may be asked to stop your application, and repeat steps 1-10 on your designated day.
You may not be asked to do this. If you are asked to to this, determine which days you can file a claim, and visit <http://labor.ny.gov> on one of those days.
11. File your claim.
12. Once you submit your claim, this is the point at which you should be given your confirmation number!
13. Unfortunately, the system may still give you trouble. If it does, repeat steps 1-12 until it results in a confirmation number.

Effective Days

Each day in a week (Monday through Sunday) that you qualify for benefits is called an effective day. There is a maximum of 4 effective days each week, and you must qualify for all 4 effective days in order to receive your total weekly benefit rate. For each day in the week that you are not eligible to receive benefits, you will receive one less effective day, which is equivalent to one fourth of your weekly benefit rate. For example, if you are not available to work one day in a week, or if you have worked any part of a day, or have received vacation or holiday pay for one day in a week, your benefits will be reduced by one effective day (the same as one-quarter of your benefit rate). You can receive a maximum of 104 effective days on your claim.

If three days have passed since a payment was released and the funds are not in your account, you should contact KeyBank Customer Service at (866) 295-2955 if you have a debit card. If you have direct deposit, contact your bank. If there is a holiday in a given week, payments may be delayed by one day that week.
