WHEREAS, Eric M. Kelley began his illustrious career as an Investigator with the Broome County District Attorney's Office in 1997, the esteemed position from which he retired in 2021; and

WHEREAS, In this capacity, Eric M. Kelley was involved in felony and misdemeanor crimes, specifically in the interrogation of suspects and interviewing witnesses, the gathering and management of evidence, drafting and executing warrants, making arrests, and other law enforcement related duties; and

WHEREAS, For more than three decades, Eric M. Kelley has been a dedicated and valuable asset to both the Broome County District Attorney's Office and the Broome County Public Defender's Office; and

WHEREAS, In addition to his work in County government, Eric M. Kelley has served as an Adjunct Professor for SUNY Broome Community College since 2006, where he taught Criminal Investigation, a lecture
