WHEREAS, This skilled woman has been the proud recipient of numerous awards and accolades, including All Around Woman of the Year by the Times in Huntington, American Cancer Society Silver Sword Award, and the Town Clerk of the Year Award by the New York State Town Clerks' Association, recognizing her achievements in promoting the role of town clerks through her professionalism and thorough knowledge of the position; and

WHEREAS, Throughout her illustrious career, Jo-Ann Raia rendered faithful, conscientious and valuable service to the Town of Huntington; and

WHEREAS, In her capacity as Town Clerk, Jo-Ann Raia served with loyalty, honor and distinction, truly earning the admiration, esteem and affection of her colleagues and the community-at-large; and

WHEREAS, With her throughout have been her two children, Diane and Andrew, both of whom feel privileged to be a part of her life and rejoice in her many achievements; and
