in which students from kindergarten through college learn how to think
divergently by working as a team to solve an open-ended problem; and

WHEREAS, As part of the Odyssey of the Mind program, students also
learn creativity, innovation, problem-solving, critical thinking, global
awareness, interpersonal and collaborative communication skills,
self-directions and adaptability; and

WHEREAS, Problem 1 was titled: OMer the ROMER, for Divisions I, II,
III & IV; OMers are always looking for new fun, and funny, experiences;
teams were asked to design and build a ride-on vehicle that would take
an OMer character on an adventure in search of humor; the vehicle used

stored energy as it was propelled forward and in reverse; at each stop, the vehicle and the OMer were asked to react to something humorous before traveling to the next destination; the humorous performance also included an unplanned stop where the OMer character took a selfie, a creative physical representation of the selfie, and a vehicle-produced special effect; and

WHEREAS, In addition to winning first place for their exceptional solution to Problem 1, this talented team received its fourth Ranatra Fusca Award, which is presented to teams or individuals who exhibit exceptional creativity, either through some aspect of their problem solution, or an extraordinary idea beyond the problem solution; and
