Moy is a nationally recognized leader, writer, and trainer in the civil legal aid community; with areas of expertise in leadership development and diversity, she currently serves on the ABA's Diversity and Inclusion Council and is Chair of the ABA's Coalition on Racial and Ethnic Justice; and

WHEREAS, With a steadfast and unwavering commitment to her community, Lillian M. Moy is past Chair of the Civil Policy Group and a past member of the Board of the National Legal Aid and Defender Association; she serves on the New York State Bar Association's President's Committee on Access to Justice, Committee on Legal Aid, and Committee on Diversity and Inclusion; and

WHEREAS, Furthermore, this extraordinary woman is co-convenor of the New York Diversity Coalition, a group of legal services staff and managers dedicated to raising and resolving diversity issues in the legal aid community; and

WHEREAS, Lillian M. Moy has been the proud recipient of numerous awards and accolades from countless organizations, including the

National Organization of Legal Services Workers, the Albany-Colonie Regional Chamber of Commerce, the Asian American Bar Association of New York, the Schenectady County Bar Association, the New York State Bar

Association, Albany County, and the Catholic Charities Housing Office;
