WHEREAS, Throughout his illustrious tenure, which has traversed five decades, John Tassiello has served in numerous leadership positions, including 1st Battalion: past Chairman and current Treasurer; Department: Chief of Department, Treasurer, 1st Lieutenant Fire Police Unit, President NHP Chiefs Association, and Awards Chairman; Company: ex-Captain, Past President, Past Treasurer, and Chairman of the 2004 Truck Committee; and

WHEREAS, Furthermore, this extraordinary man currently serves as President of the Fire Chiefs Council of Nassau County; and

WHEREAS, Firefighters unwaveringly serve our great State with pride, valor, and integrity; these respected volunteers are often the first to respond to an emergency, whether the emergency is a fire, transportation accident, natural disaster, act of terrorism, medical crisis, or spill of hazardous materials; and
