WHEREAS, Ralph Macchio went on to star in two sequels, "The Karate Kid Part II" and "The Karate Kid Part III," along with many other movies, television shows and plays; and

WHEREAS, In 2018, Ralph Macchio reprised his role as Daniel LaRusso in "Cobra Kai", an action comedy-drama Netflix series, in which he also serves as co-executive producer; and

WHEREAS, With him throughout have been his wife the former Phyllis Fierro and their two children, Julia and Daniel, all of whom feel privileged to be a part of his life and rejoice in his achievements; and

WHEREAS, Ralph Macchio has clearly made a contribution to the spirit of excellence which is a tradition of his Suffolk community; and
