WHEREAS, It is with profound sorrow and deep regret that this Legislative Body records the passing of Mark A. Rutherford, of Bedford Hills, New York, who died on Saturday, February 5, 2022, at the age of 65; and

WHEREAS, Mark A. Rutherford was a man of many passions; he was an avid outdoorsman who loved to hunt and fish and raced his street stock car number 21R for Rutherford Racing at the Middletown Dirt Track Racing circuit; and

WHEREAS, Predeceased by his parents and brother, James L. Rutherford, Jr., Mark A. Rutherford is survived by one sister, Karen Hanratty; one nephew, James Rutherford III; his nephew's mother, Ruthanne Bowles of Warwick; and numerous friends, colleagues and fellow firefighters who will long cherish his kind and generous spirit; and
