WHEREAS, Clint Adam Hollingsworth of Tupper Lake, New York, died on  
Tuesday, February 15, 2022, at the age of 47; and

WHEREAS, Born on December 19, 1974, Clint Adam Hollingsworth was a  
native to Tupper Lake, attending Tupper Lake Central School before  
attending Herkimer Community College, and later, North Country Community  
College, where he received a degree in Business; and

WHEREAS, Clint Adam Hollingsworth distinguished himself in his  
profession and by his sincere dedication and substantial contribution to  
the welfare of his community; and

WHEREAS, His commitment to excellence, and his spirit of humanity,  
carried over into all fields of enterprise, including charitable and  
civic endeavors; and

WHEREAS, A respected businessman and contractor, Clint Adam Hollingsworth owned and operated Hollingsworth Carpentry and Renovation for 17 years; one of his latest projects was the development and construction of the Sunnyside Cabins vacation rentals in Tupper Lake; and

WHEREAS, Clint Adam Hollingsworth served his community in the capacity of a village trustee on the Tupper Lake Village Board for more than two terms and most recently was appointed the Town of Tupper Lake Supervisor; he also served as the judge for the Town of Piercefield where he was proud to have officiated many weddings; he led in both positions with noticeable passion, and was a visionary for his beloved hometown; and

WHEREAS, Hobbies of his included singing and playing music with his band The Frickerz, spending time out on the lake, relaxing by a campfire telling stories and reliving past adventures, skiing with his wife and kids, playing ice hockey, and enjoying hunting with friends and family; and

WHEREAS, Clint Adam Hollingsworth is survived by his wife, Alison; daughter, Lily; son, Cash; his parents, Michelle Hutchins and her fiance Ricky Tessier, and Armon "Tinker" and Glenda Hollingsworth; grandmother, Sula Mandigo; mother-in-law, Marie Lewis; step-sister, Traci Goff; in-laws, Robert (Cindy) Lewis, Natalie (Ed) McMahon, Monica (Steve) Gagnon, Heather Naegele, Tracy (Jerry) Fletcher and Jack Lewis; as well as many nieces and nephews and numerous cousins, including Melissa Howard who he cherished like a sister; and
