WHEREAS, Since 2018, Libby Post and Sheila Healy have run the political consulting firm, Progressive Elections, LLC, specializing in local elections; Libby and her business partner have had tremendous success electing pro-choice, pro-LGBTQ candidates since starting the firm; and

WHEREAS, Through her public affairs work, Libby Post runs the New York State Animal Protection Federation and represents the state's network of animal shelters at the capitol where she has been successful in garnering support for homeless companion animals including the establishment of the Companion Animal Capital Fund which will receive \$10M in funding in the FY23 state budget; and

WHEREAS, Libby Post has been a regular on WAMC's "The Roundtable" for over a decade, and is the founding co-chair of CapitalWomen, the Capital Region's political action committee; she is also an adjunct professor at the University at Albany's Rockefeller College of Public

Affairs and Policy where she teaches "The Science and Art of Political Campaigns" and "Making Policy Understandable"; and

WHEREAS, With her throughout have been her partner of 27 years, Lynn

Dunning-Vaughn, and their son Alex, both of whom feel privileged to be a part of her life and rejoice in her achievements; and
