WHEREAS, This Legislative Body is justly proud to honor Linda Mirels, on behalf of the Kirsh Foundation, upon the occasion of her designation as recipient of the Barbara and Ira A. WHEREAS, Dedicated to making her community a better place to live, work, and play, Linda Mirels is an honorary lifetime member of the Board of UJA-Federation of New York and served as Chair of the Board; she was appointed to the position of co-Chair of the New York-Israel Commission, responsible for creating a framework to strengthen economic and cultural ties between New York and Israel; and

WHEREAS, Currently, Linda Mirels serves as a member of the Boards of Directors for the American Jewish Committee, the Israel Campus Coalition, the Tony Blair Foundation, and The Metropolitan Opera; and

WHEREAS, Linda Mirels also serves on the advisory board of her family's foundation, the Kirsh Foundation, which engages in a range of philanthropic endeavors designed to foster self-sufficiency and entrepreneurship primarily in Sub Saharan Africa and Israel; and

WHEREAS, Throughout her life, Linda Mirels has truly lived by her family's philanthropic philosophy, "give a man a fish, you feed him for a day: teach a man to fish, you feed him for a lifetime"; and

WHEREAS, When she is not helping someone, Linda Mirels serves as the Chair of Ki Corporation, a family holding company which manages a portfolio of diversified investments including major holdings in food

distribution and real estate; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefits of others which Linda Mirels has displayed throughout her life; and
