WHEREAS, Today, David Engelbert's daughter Sarah is the fourth generation to run the successful jewelry business; she was the first in her family to earn a Graduate Gemologist degree from the Gemological Institute of America (GIA); and

WHEREAS, For the last 25 years, Engelbert's Jewelers has belonged to the Independent Jewelers Organization (IJO) which only accepts jewelers with the highest ethical standards and superior professional integrity; it is also a IJO certified gem lab because of their consistency of delivering quality gems and jewelry to their customers; and

WHEREAS, Engelbert's Jewelers has specialized in "Ideal Cut" diamonds and have traveled from Antwerp, Belgium to Johannesburg, South Africa to offer their customers the best diamonds available; their jewelry and gift collection has been personally chosen so that they can offer the best quality, style and value; and
