WHEREAS, The recipient of numerous awards and accolades, ex-Chief Anthony Gallo received the Class B Life Saving Award from the Town of Babylon's Fire Association, and received recognition in 1982 for performing life-saving cardiopulmonary resuscitation on an infant; and

WHEREAS, Volunteer firefighters unwaveringly serve our great State with pride, valor, and integrity; these respected volunteers are often the first to respond to an emergency, whether the emergency is a fire, transportation accident, natural disaster, act of terrorism, medical crisis, or spill of hazardous materials; and

WHEREAS, With him throughout have been his wife, Eleanor, their two children, Brian and Jennifer, and two grandchildren, Michael and Kylie, all of whom feel privileged to be a part of his life and rejoice in his many achievements; and

WHEREAS, It takes a special dedication, a strong desire to help others and a tireless sense of community to forsake precious time with family and friends to respond to the signal that a neighbor is in need;
