WHEREAS, James Gilliland was the proud recipient of the 1992 EMT of the Year Award for successfully delivering and resuscitating a newborn in transit to the hospital; and

WHEREAS, Contributing to the emergency medical services since 1986, James Gilliland has continued to elevate his level of training, beginning as an EMT, and attaining certification as an EMT-CC and EMT-Paramedic; he is currently an EMT instructor throughout Suffolk County; and

WHEREAS, His special commitment, patience, and dedication to educate students and residents in emergency medical care remains a valuable contribution; and

WHEREAS, Firefighters unwaveringly serve our great State with pride, valor, and integrity; these respected volunteers are often the first to respond to an emergency, whether the emergency is a fire, transportation accident, natural disaster, act of terrorism, medical crisis, or spill of hazardous materials; and
