being named Boys Cross Country Coach of the Year for
New York State by US Track and Field and Cross

the fall season, which requires a combined academic average of 90 or

Boys and Girls Cross Country Teams captured the Southern Tier Athletic

Conference Championships, the Section IV Championships, and the Class A State Championships; and

WHEREAS, Furthermore, Jack Gregorski won Cross Country States and qualified for individual Nationals, and his daughter, Sarah Lawson, earned a spot on the podium at States; and

WHEREAS, Ray Lawson's positive demeanor, selfless commitment, and caring concern have contributed to his enduring success as a coach and mentor, earning him the just respect and admiration of his community, his peers, and the athletes he has so ably coached; and
