WHEREAS, Named after the distinctively-shaped lighthouse that guides ships passing Orient Point to their destinations, Coffee Pot Cellars is the realization of veteran North Folk winemaker Adam Suprenant who combines grapes from expertly-farmed vineyards with the winemaking skills he has honed over a distinguished career which includes a UC-Davis Master's degree, training at Chateau Lafite-Rothschild and top Napa Valley wineries, and over 20 years of making award-winning, critically-acclaimed wine on the North Folk; and

WHEREAS, Remaining true to its mission, Coffee Pot Cellars will continue to make remarkably good and interesting wines from the best fruit North Folk vineyards can provide; and

WHEREAS, Over its distinguished history, this esteemed vineyard has demonstrated continuous service to the residents and communities which it serves; and
