WHEREAS, Despite going through challenges and closing for 100 days during the pandemic, the Marr-Logg House has remained busy throughout its distinguished history; its staff, who consider one another family, have tirelessly served the community together for 50 years; and

WHEREAS, Furthermore, the restaurant has served as the starting off point for many people in the community, including John Marraffa's own children, who are now professionals in toxicology and pharmacy; and

WHEREAS, The remarkable success of the Marr-Logg House is due in large part to its owners and dedicated staff whose warmth and hospitality are easily recognized by their loyal patrons; this dynamic team is well-versed in customer service and truly makes everyone who walks through their door feel like family; and

WHEREAS, For five decades, the Marr-Logg House has stood as a beloved establishment which has provided a friendly, open environment for patrons to collectively gather and share their thoughts, ideas and life experiences; and

WHEREAS, It is with great pleasure that this Legislative Body acknowledges this exceptional business and its contributions to the
