WHEREAS, In addition to winning the Governor's Cup, Wolffer Estate Vineyard, based in Sagaponack, New York, also received a Platinum Medal for Best Dessert Wine with their 2020 Diosa Late-Harvest; and

WHEREAS, Judging for the New York State Wine Classic took place from April 15 through June 15, 2022, and included 694 entries from 101 wineries across the state, with the Wolffer Estate Vineyard finishing at the top; and

WHEREAS, Founded by Christian Wolffer in 1988, the vineyard has been one of the finest producers of wine in New York State for over 30 years; Wolffer Estate Vineyard is currently owned and operated by the founder's children, Marc and Joey Wolffer, along with Winemaker and Partner Roman Roth; and
