COMMEMORATING the 50th Anniversary of the  
Patterson Historical Society

WHEREAS, Over its distinguished 50-year history, the Patterson Historical Society has demonstrated continuous service to the residents and communities which it serves; and

WHEREAS, The success of the Patterson Historical Society is in direct correlation to the efforts of its dedicated board members, staff and volunteers, whose involvement is, and always has been, characterized by an impressive commitment, an unbridled enthusiasm, and an uncompromising standard of excellence in all endeavors on behalf of the organization and the community it serves; and
