WHEREAS, Firefighters unwaveringly serve our great State with pride, valor, and integrity; these respected volunteers are often the first to respond to an emergency, whether the emergency is a fire, transportation accident, natural disaster, act of terrorism, medical crisis, or spill of hazardous materials; and

WHEREAS, It takes a special dedication, a strong desire to help others and a tireless sense of community to forsake precious time with family and friends to respond to the signal that a neighbor is in need; Sean O'Donnell is such a firefighter; throughout his years of devoted service, this volunteer heroically performed, above and beyond the call of duty, those responsibilities which define the task of fire protection; now, therefore, be it
