Governor Cuomo Unveils 2012-13 Executive Budget Proposal



I met with Governor Andrew Cuomo at the State Capitol Tuesday for the Governor's Executive Budget proposal.

Dear Neighbor,

As your Senator, I have been leading the fight to reduce government spending and save money for hardworking, overburdened taxpayers.

Last year, the Senate passed an on-time budget that achieved our critically important goals of controlling spending, avoiding tax increases and helping to create new private sector jobs. As Chairman of the Senate Committee on Commerce, Economic Development and Small Business, I worked closely with Governor Cuomo and Lt. Gov. Duffy to put forth many proposals included in the final budget negotiations – most noticeably the creation of the Regional Economic Development Councils that have distributed nearly \$1 billion in money for economic revitalization and job growth in New York State.
