NYS Water Quality Hearing
Re: Hoosick Falls PFOA contamination

Kathleen Main-Lingener- Village Resident

Senator Marichone, Senator Hannon and Senator O'Mara I want to thank you for this opportunity to address the PFOA water crisis in Hoosick Falls NY

What this issue means to me on a personal level is mistrust in the local and state officials that are supposed to and did not protect the community it served. The village was advised of the possible contamination in August of 2014 they were presented with testing that had been completed that showed that the levels of PFOA in the water exceeded the 2009 EPA recommendation 400 PPT. Homeowners received a small notification in our water bills and was not a warning and according to the Village of Hoosick Falls was not harmful. If you were not a homeowner you did not get this notice. There have been numerous articles and research done on this chemical prior to August 2014. There was enough literature to direct the Village of Hoosick Falls to advise the people to NOT ingest this chemical. Just days prior to being advised by the EPA to no longer use the water the Mayor and NYS DOH advised that the water was safe and it was a personal choice. A personal choice to consume water that was harmful to myself, my family and my neighbors. That does not qualify as the right to warn they hid the fact that the chemical was present and that it was harmful for 18 months. 18 months where pregnant woman newborn babies and small children continued to ingest this chemical. As a mother who raised her child in Hoosick Falls and lived in the community for 20 years I had a strong feeling of guilt for bringing my family here. All though we cannot change the past we must put precautions in place to never allow this to happen in the future. The Village Municipality, NYS DOH and the EPA all need to be held accountable for the 18 months that could have made a difference to so many people. All though I do not hold the government accountable for the actual contamination I do believe they should be held accountable for not protecting those they serve. The news of water contamination would have put a halt to new business or people moving into the community to support the Hoosick Rising initiative. I feel that the Village made a conscious decision to withhold this information to move forward with that project putting financial gain over the wellbeing of the residents

As a consumer of the municipal water system in Hoosick Falls it is my belief to have had the right to be given the opportunity to determine for myself what was safe and acceptable for my family. If any other service provider outside a municipality were to do this exact same thing there would be consequences for their actions. All though the 6 months of water rebate was something what about the other 12 months we paid to be poisoned. NYS DOH should not have gone on the basis that this was an "unspecified organic material" allowing 50000 PPT as acceptable. I am unclear how

that could be acceptable when there was clearly a level set by the EPA specifically for PFOA that was documented. It appears in my opinion that NYS was washing their hands of this small town with a water problem hoping it would disappear and the EPA had to step in to protect the community. I also believe that the Village officials had a moral obligation to make the community aware of the contamination.

I would also like to touch on the help that was provided by the State of New York. This was no more than a display by the State and County officials to make it appear that help was provided. With each encounter my frustration grew and my questions were never answered. I am a home owner that had their property on the market prior to knowing about the water. All though my property value is not the responsibility of the Local and State officials the help that was provided was very disappointing to say the least. The gentleman I spoke with told me my property value had not declined but I showed him proof that it had. My property went on the market in April 2015 for 144900.00 after the water was discovered my property value fell to 99500.00. When I discussed this with them they simply told me that I should take it off the market and wait. This was the help I received I was already selling and did not want to put my future on hold and my property was already on the market for almost a year. Well here I am 6 months later and I can't get an appraisal that is even remotely close to one another. In order to sell I have had to go through a short sale process which has ruined my credit. I did this with a buyer in mind, stopped paying the mortgage so the bank would except less than I owed and the buyer backed out. I have not had one showing of my home since May 2016 and I have no idea what the value of my property is. What I do know is the value is much less than what I am currently paying for property taxes and what I owe the bank.

My next interaction with help from NYS consisted of the DOH (Neil) who I went to get information on my blood test results. When I inquired about the C8 panels finding it was downplayed. I have lost my father, uncle, aunt and mother all within the last 2 years and all to cancer, I had a valid concern did the PFOA in my blood make me more susceptible to cancer? The gentleman at the DOH advised that if I was going to get cancer I would get it anyways. This did not sit well with me this gentleman did not have any facts he downplayed the C8 panel and basically laughed at me when I asked if he had read about DuPont. My mother who lived in the village died of pancreatic cancer in July of this year and my aunt who lived next to the Chemfab plant in VT died in June of this year. That's two (64 and 67) sisters who died just over 1 month of each other so imagine my horror and concern about having this in my system. The DOH representatives were not educated on PFOA exposure they were sent with a script to read and that is not help that is the DOH covering the bases. The created great frustration within the community.

As a solution to this problem I would like to request that medical monitoring for all communities and a clean water source be instituted under the Superfund. This would place the costs on the polluter and allow the communities to move forward. There needs to be procedures put into place that is shared with all New York State agencies to handle emerging PFOA contamination in the State. I am doing everything I can to prevent any more exposure to PFOA and filtering the water is not an option. Even though it is nondetect it really isn't non detect it is just below the 70 ppt that in my opinion is too high. These communities have been exposed and further exposure even 2 ppt in the water is too much the only acceptable level is 0.

Safe clean drinking water isn't a luxury it is a right and it is a service that we all pay the Village to provide. I would like to thank you for your time and the opportunity to speak in this important matter for the continued health and support of the residents of Hoosick Falls, Hoosick and Peterburgh.

Outside of my verbal testimony please see the enclosed information for your review. I have enclosed timeline of events, the original petition, all signatures and comments requesting these hearing to see how the public is reacting.

Government Breakdown:

- August 2014 failure to advise community that the municipal drinking water was contaminated.
- 2014-2015-Lots of discussion on water problem without public knowledge
- December 2015 Village and DOH official announce water is clean that it is a personal choice to consume
- December 2015 EPA stepped in and advised that Village and State tip sheet be removed as it was incorrect.
- January 2016 NYS site Saint Gobain as a Superfund site 10 million awarded for assistance.
- February 2016 NYS sends mobile unit to Hoosick Falls to provide help for homeowners. This was not help this was one man in the armory with no more information than my mortgage company had. My Mortgage company actually had more information. No information was obtained I instead found myself educating him on the loss of property value from the school.
- March 2016 Empty chemical barrel sitting on the side of the road on Rt22 by the school. This was there for 2 days I requested that the DEC pick up the barrel which contained Sodium Hypo chlorite (used for cleaning municipal water systems) The DEC was brought to the empty barrel they kicked it and said it empty what would you like me to do and got in their trucks and drove away. I had to personally go over and ask an ENCON officer to please have it picked up. This was the day Gov Cuomo came to town and he would have also driven by the barrel riding through town.




- May 2016 Hearing are cancelled and not rescheduled
- December 2015 called for blood testing never received an appointment. Needed to call back in February to obtain appointment no call back.
- February 2016 family went to armory and sat through questionnaire and received blood draw.
- May and June 2016 pending blood test results delayed multiple times

- June 2016 Blood test results were sent out on a weekend when nobody could answer questions
- June 2016 DOH went to get information on blood testing which was not helpful. They did not have any information
- June 2016 Went to Capital and met with Jim Malatras who discussed my DOH experience. We discussed sending Mt Sinai team to explain PFOA blood results given a direct contact who did not respond to emails.
- July 2016 Mt Sinai came to the area there was 1 person for all residents. Long waits and the gentleman was not prepared and did not have any blood work information from the NYS DOH
- Village physicians were not educated on the effects of PFOA changed physician to a Vermont Dr. who had training via Vermont State and was educated on the medical implications.
- Watching the neighboring state of Vermont and how they handled this brings concern over how NY has handled.
- Political blame game the village blames the Department of Health the Department of health blames the EPA. If the residents were advised and the agencies worked together this could have all been avoided.
- Help only provided when public pressure was placed on officials. Gov Cuomo only came to town when called out and the meeting was private, The Mobile Mortgage bus was sent when the question of home value was pressed, the DOH only came when the blood test results were under scrutiny. These are all things that should have occurred without public pressure but for the good of the people.

This is a short version of the list but the unorganized and disrespectful behaviors by the DOH added to the communities' frustration. This money could have and should have been spent on finding a new water source.

UPDATE: Residents were recently delivered blood test results provided by the DOH to determine the exposure to the chemical PFOA. The numbers are staggering and especially in the children. The 6 year boy in the picture above could have shaved off one and half years of exposure if we were notified. This would have been beneficial to HIM and all the other children and members of these communities. Please note the average number for PFOA in blood is between 2 and 5. His was 142!!! We DEMAND these hearings for these KIDS!!

The small communities of Hoosick Falls and Petersburg were recently both found to have contaminated drinking water due to a "Non-Stick" man made product used in the manufacturing

of Teflon. The contaminant is a substance called PFOA (Perfluorooctanoic Acid) or C8. The man made substance has been linked to several types of CANCER (Kidney, testicular and other types), Thyroid Disease, Ulcerative Colitis, Pregnancy Induced Hypertension, Reproductive Disorders, Developmental Delays, Severe Birth Defects and other types of illness. The Citizens of these small communities are DEMANDING that there be public hearings on a State or Federal level to determine why Residents were not notified immediately when the chemical PFOA was discovered by the NYS Department of Health, Department of Environmental Conservation, EPA and the Local Village Leaders. In Hoosick Falls the contamination was found by a Private Citizen who had lost his Father to Kidney Cancer and started to investigate a reason why. The PFOA contamination was reported to the Village Mayor, NYS Department of Health as well as the EPA and The Department of Environmental Conservation in August of 2014. Members of these small communities have many unanswered questions. Why did it take so long for our Government Officials to tell us about the high levels of this contaminant PFOA in our drinking water? Why there was not regard to the health and public safety of these communities to a point where we were notified to stop using the drinking water in 2014? The community was not notified for almost a year and a half after the contaminant was brought to the Village of Hoosick Falls attention in August 2014. The EPA stepped up in December 2015 and advised the Residents to stop drinking and cooking with the water. This was just days after the NYS Department of Health and the Village officials advised the water was "SAFE TO DRINK". Petersburg NY was soon to follow and was advised not to use their drinking water in February 2015. Both Manufacturers believed responsible for the contamination have been deemed a Superfund site by the EPA. We need your help getting the Public Hearings to take place with this petition. We need those accountable for those communities to be held responsible for not informing the public of the poison in our drinking water. For not allowing us to protect our children's health. The NY State Assembly has canceled the promised scheduled hearings to investigate those very questions. We need to conduct those hearings not just for these small communities but for all small communities in New York State that may have similar problems in the future. The State needs to be held accountable for not protecting the people they were elected to protect and serve. No other community should ever have to go through the "not knowing" that something that is a basic human right such as water is unsafe to drink! Take a proactive step to prevent this from happening again and teaching NY Officials from their mistakes. Be heard and stand up for what's right and fight!
