Re: Environmental Toxins Surrounding the Throgs Neck Bridge

Dear President Kupferman:

On December 15th, 2009, I wrote to you outlining concerns of local residents involving lead and other contaminants emanating from construction at the Throgs Neck Bridge. I received a response on your behalf from Mr. Ed Knightly in which he indicates that the concerns were unfounded. Clearly this is not the case.

Attached is data compiled by Dr. James Cervino based on laboratory tests of earth samples taken under the bridge and ramp extending various distances from the worksite. This data unequivocally identifies the presence of lead in quantities that pose a serious health hazard.

There are over a thousand children who participate in various recreational activities in this area. We are very concerned about the health dangers this situation represents for them and many others who use this park area.

In addition to the earth samples, photos were taken of piles of rubble and debris above and along the shore line which clearly contain toxic material.

The athletic groups will begin their season on April 15th. It is imperative that remedial steps be taken to remove this contaminated soil as soon as possible.

Although this situation should never have been permitted to happen it is now your responsibility to act expeditiously to restore this area to its prior condition.

By copy of this letter I am requesting that the Department of Environmental Conservation investigate the work site, review the test data developed by Dr. Cervino, and monitor the remedial steps you must take.

I look forward to your earliest possible response.
