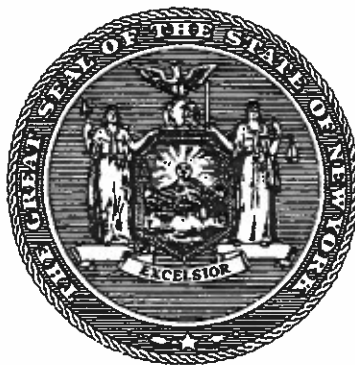

WHEREAS, It is the custom of this Legislative Body to pay tribute to public servants of the State of New York whose lifework and civic endeavor served to enhance the quality of life in their communities and this great Empire State; and

WHEREAS, Christopher J. Mega, a former New York State Senator, Assemblyman and State Judge who was well-known for his prolific career, work ethic and omnipresence at community events, died on Sunday, October 30, 2011, at his home in Saratoga Springs, New York, at the age of 80; and

WHEREAS, A graduate of Fort Hamilton High School, Christopher J. Mega continued his education and studied at St. Francis College before attending Brooklyn Law School; and

WHEREAS, His first job was as an attorney at a Fifth Avenue law firm, where he was a partner; in 1973, he ran for an open seat in the 50th New York State Assembly District during a special election, a seat he held until 1978; he then ran and won his first New York State Senate seat, represented Bay Ridge, Dyker Heights and Sunset Park from 1979 to 1982, and 1985 to 1993 when he became a judge; and

WHEREAS, He served as Chairman of the State Senate's Crime and Correction Committee during efforts to ban the sale of serial killer trading cards being sold in stores; and

WHEREAS, He also became Chairman of the Senate Judiciary Committee, where, in the early 1990s, he worked to expand state prisons to accommodate the huge influx of inmates convicted on crack-related charges; furthermore, he was an advocate for tougher sentences for convicted sex offenders; and

WHEREAS, Senator Christopher J. Mega helped bring pre-kindergarten programs to his district and sponsored the bill that required restaurants to display posters showing Heimlich maneuver instructions in their eateries; and

WHEREAS, In 1993, Christopher J. Mega attained his ultimate career goal; he was appointed to the New York Court of Claims, and in 1995 he was elevated to Chief Judge of the State Court of Claims, a panel that hears lawsuits filed against the State of New York; he served in this capacity until stepping down in 1998; he was then appointed to the New York Supreme Court serving until his retirement in 2006; and

WHEREAS, With a strong belief in the community, Christopher J. Mega donated his time and energies to numerous civic and charitable organizations such as the Dyker Heights Civic Association and the Bay Ridge Lions Club; and

WHEREAS, Christopher J. Mega is survived by his loving wife, Madelyn; twin sons, Christopher and Jeffrey; and two daughters, Valerie and Jacqueline; as well as his grandchildren; and

WHEREAS, The legacy of Christopher J. Mega will long serve as a model of integrity and devotion to public service, and it is now the intent of this Legislative Body to inscribe upon its records this somber and grateful tribute to his memory, hopeful that future generations may understand and appreciate the benevolence of the man, the merit of his causes, and the caliber of his service to all the citizens of the State of New York; now, therefore, be it

RESOLVED, That this Legislative Body pause in its deliberations to mourn the death of Christopher J. Mega, highly respected politician, distinguished citizen and devoted member of his community, and to express its deepest condolences to his family; and be it further
